Description of Scorecard Factors:

Motion to Instruct Conferees on H.R. 2863: This Motion to Instruct directed House conferees to agree to the Detainee Treatment Act provisions in the Senate's version of H.R. 2863. The Detainee Treatment Act reaffirmed U.S. obligations under the Convention Against Torture to prohibit cruel, inhuman or degrading treatment or punishment. It also requires military interrogators to follow the Army Field Manual while conducting interrogations. Representatives who voted in favor of the motion earned a √. Representatives who voted against the motion earned a —.

S. 3930: The Military Commissions Act authorized the President to define what acts constitute torture, and eliminated the protection of habeas corpus for non-citizen detainees. It also allowed for the use of evidence obtained through torture. Representatives who voted against the bill earned a √. Representatives who voted in favor of the bill earned a —.

H.R. 2826 & H.R. 1415: These bills would have allowed detainees habeas corpus rights. Representatives who co-sponsored either or both bills earned a √. Representatives who did not cosponsor either bill earned a —.

H.R. 2082: A provision in this bill would have required all government agencies, including the CIA, to abide by the guidelines in the Army Field Manual while conducting interrogations. The U.S. Army Field Manual prohibits torture, cruelty, and humiliating and degrading treatment of detainees and requires interrogators to follow a “golden rule” approach to interrogations. Representatives who voted in favor of the bill earned a √. Representatives who voted against the bill earned a —.

H.R. 2082 Veto Override: President Bush vetoed H.R. 2082 because it would have ended torture. The House then took a vote on overriding that veto. Representatives who voted in favor of overriding the veto earned a √. Representatives who voted against overriding the veto earned a —.

Amendment 220 to H.R. 2847: Amendment 220 was intended to keep the detention center at Guantanamo Bay open by denying the Administration the funds needed to close it. Representatives who voted in favor of the amendment earned a —. Representatives who voted against the amendment earned a √.

Amendment 270 to H.R. 2647: Amendment 270 requires that interrogations of detainees in Department of Defense custody be videotaped. Videotaping interrogations protects detainees from abuse and protects interrogators from being falsely accused of abusing detainees. Representatives who voted in favor of the amendment earned a √. Representatives who voted against it earned a —.

Amendment 327 to H.R. 1540: Amendment 327 would have removed a provision from H.R. 1540 that would have allowed for the indefinite military detention without trial of people captured anywhere in the world. Representatives who voted in favor of the amendment earned a √. Representatives who voted against it earned a —.

Amendment 1127 to H.R. 4310: Amendment 1127 would have prevented the indefinite military detention without trial of people captured in the United States. Representatives who voted in favor of the amendment earned a √. Representatives who voted against it earned a —.

Formula: For the purposes of calculating each Representative's score, each √ equals 1. Each — equals - 1. Each X equals 0.
Score = 50 + 50[(sum of √s and —s)/total votes while in office].
