## Description of Scorecard Factors:

**To Create a Common Humane Standard for Interrogations (Based on the Army Field Manual):** A provision in H.R. 2082 would have required all government agencies, including the CIA, to abide by the guidelines in the Army Field Manual while conducting interrogations. The U.S. Army Field Manual prohibits torture, cruelty, and humiliating and degrading treatment of detainees and requires interrogators to follow a “golden rule” approach to interrogations. Representatives who voted in favor of the bill earned a √. Representatives who voted against the bill earned a —.

**To Require Certain Interrogations be Videotaped:** Amendment 270 to H.R. 2647 required that interrogations of detainees in Department of Defense custody be videotaped. Videotaping interrogations protects detainees from abuse and protects interrogators from being falsely accused of abusing detainees. Representatives who voted in favor of the amendment earned a √. Representatives who voted against it earned a —.

**Against Allowing World-Wide Indefinite Detention Without Trial:** Amendment 327 to H.R. 1540 would have removed a provision from H.R. 1540 that would have allowed for the indefinite military detention without trial of people captured anywhere in the world. Representatives who voted in favor of the amendment earned a √. Representatives who voted against it earned a —.

**Against Indefinite Detention Without Trial of People Captured in the U.S.:** Amendment 1127 to H.R. 4310 would have prevented the indefinite military detention without trial of people captured in the United States. Representatives who voted in favor of the amendment earned a √. Representatives who voted against it earned a —.

**In Opposition to a Ban on Transferring Detainees to Yemen:** Amendment 901 to H.R. 4870 prohibited any funds to be used to transfer detainees held at Guantanamo to Yemen. Representatives who voted against the amendment earned a √. Representatives who voted in favor of the amendment earned a —.

**In Opposition to a Ban on Transferring Detainees out of Guantanamo:** Amendment 905 to H.R. 4870 prohibited any funds to be used to transfers detainees held at Guantanamo to any foreign country. Representatives who voted against the amendment earned a √. Representatives who voted in favor of the amendment earned a —.

**In opposition to a total ban on transfers out of Guantanamo:** H.R. 5351 would ban all transfers out of Guantanamo. It would prevent transfers even our government doesn't consider the detainee a threat. It would even prevent detainees who had been found innocent of ever having any connection with terrorism from being transferred out of Guantanamo.

**Formula:** For the purposes of calculating each Representative's score, each √ equals 1. Each — equals - 1. Each X equals 0.

Score = 50 + 50[(sum of √s and —s)/total votes while in office].

\*\*Representatives Ryan and Pelosi are not scored for the votes they skipped. Speakers of the House traditionally do not vote on most questions.
